<u>Item 4</u>:

Chief of Utility Operations - TAD

Per authorization at the February 20, 2018, Board meeting, the Chairman presented an employment agreement to Robert Munro; and, with minor changes, Mr. Munro accepted the offer to become Avon Lake Regional Water's next Chief of Utility Operations beginning on March 19, 2018.

The Principles that would help guide the Board are:

- ♦ Sustain an empowered, skilled, quality workforce with a commitment to innovation.
- Exercise fiduciary responsibility.

Recommended Motion:

I move to confirm the employment agreement between Robert Munro and the Board of Municipal Utilities.

Item 5A1: Underground Asset Locator – TAD

At its June 6, 2017, meeting the Board approved the job description for the Underground Asset Locator, which was then approved by Council on July 10, 2017. With the approval of wage steps with the Union Agreement, the Civil Service Commission was able to advertise and test for the position in January. Staff interviewed the top five candidates and selected George Caruso, whom has served as an inspector for Avon Lake Regional Water for more than seven years (as a LORCO inspector 1/10 – 11/11 and for our projects since 11/12). Prior to working for us, Mr. Caruso spent nearly 20 years working for various engineering firms on a survey crew, inspecting construction, and drafting. As either we bring in additional inspectors or as the level of on-going construction cuts back, Mr. Caruso will begin taking over locating work. He will begin fulltime, permanent work with Avon Lake Regional Water as an Underground Asset Locator wage step 1C beginning March 5, 2018.

<u>Item 5A2</u>: Part-Time, Temporary Inspectors – TAD

In order to assure that construction by the five UUI crews working on the 45 sewer separation was proceeding appropriately and according to plan, management temporarily reassigned two staff members from the Water Reclamation Facility (WRF) to inspect the construction. Due to intended startups at the WRF, one of those temporarily reassigned will return to his normal operations. Hence, to maintain appropriate oversight of construction, Dale Mitchell, a former WRF operator and a master plumber, will be temporarily employed by Avon Lake Regional Water at \$26.00/hr beginning March 5, 2018, to inspect construction.

Also, Lindsey Bruce, the former Line Maintenance Leader, will be temporarily employed by Avon Lake Regional Water part-time at \$26.00/hr beginning March 5, 2018, in order to help with lateral inspections. This will both reduce overtime paid to others and/or allow the Distribution and Collection crew to better focus on other priorities.

Item 5A3: **Temporary Employee** – *TAD*

As per the request by the Board to hold off on permanently filling the Analyst/Assistant position and the suggestion to temporarily fill the position, the CUE is working with Area Temps and has started training an executive assistant (Dorothy Cooper) to assist until such time as a path forward for the Analyst/Assistant position is determined.

Item 5A4: **Communications** – *CMA/TAD*

Since the February 20th Board meeting, *The Press* had a piece about the wastewater rate change.

<u>Item 5A5</u>: **Project Updates** – *SCB/TAD*

Wastewater Plant: Raw pumps start up is March 8th. Screens are March 13th. The last two Finals will be online by March 20th. Press building is scheduled for April 20th for substantial completion. The connection to new headworks from the Lake Road Interceptor was completed February 28th.

Elyria Interconnection: The project is being advertised, with a bid opening date of March 9th. The loan application has been submitted to Ohio EPA.

SIP: Additional cost proposals are being solicited for the tower lighting and project closeout documents are being finalized.

Curtis Sewer Rehabilitation: The project is design/specifications are being finalized with the intention for issuing the request for bids in March and award in April.

Item 5A6: Lateral Updates – TAD

The lateral separation program continues to progress. As of March 2, 2018, letters have been sent to 3,032 residents indicating that they may have clean water entering their sanitary lateral and requesting Avon Lake Regional Water be contacted to determine whether this may be the case. To date, 2,758 (91%) have responded (up 82 since 2/13/17). Of the 2,758, 2,158 either have separated laterals or already had separated laterals and 600 either have problems or are believed to have problems. By extrapolation, approximately 780 (600 + ~67% of homes not inspected) may need to separate laterals. The attached table/graphs provide additional information.

As of March 2, 2018, 118 of the homeowners with the first deadline have yet to respond and have their free inspection. It is anticipated, approximately 75 of these homes will need to address clean water in their sanitary lateral, along with the 256 homes we know have clean water entering the sanitary lateral. Therefore, about 330 need to do some work to comply with the first deadline. Additionally, all Resolution of Necessity Letters have been sent to those with the first deadline; we are in the midst of sending letters to those with the second deadline.

The total executed Lateral Loan Program agreements are now at 269 (up 5 since February 13, 2018), with \$933,875 committed and \$462,915 paid to contractors so far. The average loan request is for approximately \$3,450.

<u>Item 5A7</u>: **CUE Report and Action Items** – *TAD*

On March 1, 2018, the CUE, serving in his role as Chair of the Ohio AWWA Water Utility Council, along with eight other water utilities, met with Ohio EPA to discuss the proposed lead regulations and asset management regulations. On March 8, 2018, the CUE will co-present with the Assistant Chief of Ohio EPA's Office of Financial Assistance regarding our lateral loan program at Ohio's One Water Government Affairs & Regulatory Workshop. Additionally, at the request of the editors, the CUE has submitted a draft feature article regarding our lateral loan program to *Water Finance & Management* magazine for its April edition.

Sewer Lateral Program

Mr. Abram moved, Mr. Phillips seconded to amend the update to the Sewer Lateral Program for the capped credit at \$1,000.00.

8. Upon Avon Lake Regional Water's acceptance of the work and any requisite approvals from the Building Department, Avon Lake Regional Water will provide a \$1,000 wastewater bill credit to the party paying the wastewater bill. This is payable quarterly over a ten-year period. The rate rebate may not be accelerated and is not transferrable. If there is a special arrangement where there are different parties responsible for payment of the work required and for payment of the wastewater services, and the party paying for the work uses a lateral loan offered by Avon Lake Regional Water, the credit may be applied to the loan principal/interest bill. Note that if the customer previously took part in the Foundation Drain Sump Disconnect program and received the \$100 or \$300 bill credit, any credit received through this program will be capped at \$1,000 total bill credit, including the previous program.

Reports/Updates

The following reports and updates were made by copy of the meeting's write-up and discussed as noted:

Extension of Agreement with SmartBill

In late November 2016, the CUE executed a contract with SmartBill of Hebron, Ohio to process and mail water and wastewater bills generated through our billing software, Muni-Link. Based upon the original recommendation of the Law Director, the agreement was executed for a one-year duration. This agreement has expired, and the CUE worked with the Law Director to renew this agreement for a two-year term with no increase in costs.

Resolution of Necessity

At its February 12, 2018, meeting, the City Council updated its original Resolution of Necessity regarding lateral inspections/separations. Avon Lake Regional Water had intended to update customers regarding the Board changing the inspection/separation deadlines and offered to serve as the designee that notifies residents of the Council's action. Letters have started going out to the approximately 900 customers/owners that must be notified. These customers/owners have either not had an inspection or still need to complete their projects. This number is down from over 1,600 whom received the first letter a year ago. Therefore, approximately 700 customers/owners moved through the process in the past year.

Communications

Since the February 6th Board meeting, *The Morning Journal* had a piece about the wastewater rate increases and *The Press* had a piece regarding the lateral inspection/separation deadline extension. *The Press* is also planning a piece on the wastewater rate change and the reasoning behind it for the February 21st issue.

Project Updates

- Wastewater Plant: SCADA continues to be installed. Pipe is being installed in the
 dewatering building for the new presses. Windows and the garage doors are
 being installed at the dewatering building. Work continues on the new headworks
 facility, with anticipated start-up within the next month.
- Elyria Interconnection: The project is being advertised, with a bid opening date of March 9th.
- SIP: Additional cost proposals are being solicited for the tower lighting and project closeout documents are being finalized.

Lateral Updates

Sewer lateral separation and loan program numbers were updated by this meeting's write-up.

CUE Report and Action Items

Insurance: The City's deductible is \$2,500. Staff has further investigated how others respond to claims as discussed at the past meeting. In the future, staff will only consider liability if we knew about the issue that led to the problem, had sufficient time to address it, and did not.

Improved camera system for Board meetings: Staff has been working with the City's Digital Media Department and outside contractors to get quotes on updating the video recording system and intends to provide the information to the Board in March.

Improved meeting facilities: Staff understands there is a desire to consider a better-laid-out meeting room. Staff intends to work with a local architect/interior designer to complete a needs assessment for the entire building and include any Board room changes in that assessment. The intention would be to complete that assessment during 2018 and, in 2019, make any changes with which the Board wants to proceed.

Chairman Dzwonczyk moved, Mr. Phillips seconded authorization for CUO Search Committee to present job offer to candidate, Robert Munro for position of CUO.
