Item 5A1: Continuous Improvement – RKM/TAD

On Wednesday, April 11th, Tri-C conducted a training class on the subject of "Delivering Great Customer Service" that focused on identifying whom our customers are and how we can improve the level of customer service. The next staff training session with Tri-C will focus on creating SOPs.

Transitioning our training over to LCCC, we will hold our first session on April 20th at the Folger House in Avon Lake. The topic of this 4-hour training session will be "Start With 'Why".

At the last meeting there was discussion about what we were going to name our Total Quality Management (TQM) program. The CUE and CUO have discussed many of the industry standards and are currently evaluating what will fit our organization best. We are currently

incorporating a couple different standards into our training sessions that will help us to better understand what is relevant to our utility.

Item 5A4: Project Updates – RKM

Curtis Area Sanitary Sewer Rehabilitation Project: At the last meeting, a contract was awarded to Underground Utilities, Inc. (UUI) in the amount of \$1,875,352.00 and the CUE was authorized up to an additional 5% for other project-related items, including out-of-scope work with UUI. This is a project that will rehabilitate the sanitary sewer system, water main, storm sewer system and road base on Curtis Road between Redwood and Lake Roads. On April 4, 2018, a notice-to-proceed letter was sent to UUI. The week of April 16, 2018, UUI is scheduled to start the cleaning and televising of lines per the contract specifications.

Wastewater Plant: SCADA work and training is still ongoing. Primary Tank #3 is under construction for rehabilitation. The new grit removal system is in service and operational. The concrete drive is under construction and site restoration has started in some areas of the site.

SIP: Cost proposals for the addition of tower lighting are currently being prepared. This should be ready sometime in the next month. Ohio EPA determined that the lighting was not loan eligible. The last loan submittal was made on April 12, 2018, which will effectively close out the project.

Item 5A5: **Lateral Updates** – *TAD*

The lateral separation program continues to progress. As of April 11, 2018, letters have been sent to 3,041 residents indicating that they may have clean water entering their sanitary lateral and requesting Avon Lake Regional Water be contacted to determine whether this may be the case. To date, 2,853 (94%) have responded (up 95 since 3/2/17, an average of >16/wk). This number has significantly increased because staff recently called each homeowner whom had not had an inspection and had a valid phone number on file and finished sending out all of the

updated Resolution of Necessity letters. Of the 2,853, 2,277 either have come into compliance or were already in compliances (>20 confirmed each week) and 576 either have problems or are believed to have problems. By extrapolation, approximately 700 (576 + ~67% of homes not inspected) may need to do some work to come into compliance. The attached table/graphs provide additional information.

As of April 11, 2018, 74 of the homeowners with the 11/30/18 deadline have yet to respond and have their free inspection (down 44, >7/wk). It is anticipated, approximately 50 of these homes will need to address clean water in their sanitary lateral, along with the 248 homes we know have clean water entering the sanitary lateral. Therefore, about 300 need to do some work to comply by 11/30/18 (~9/wk).

The total executed Lateral Loan Program agreements are now at 279 (up 10 since March 2, 2018), with \$963,563 committed and \$550,985 paid to contractors so far. The average loan request is for approximately \$3,450. To summarize, the loan program was initiated in June 2016. Through the end of February 2018 (during those 20 months), 600 homeowners did something to comply with the requirement to remove clean water from sanitary laterals (or were determined to be in compliance). Of those 600, 260 separated laterals. Of those 260, 140 (40%) used the loan program.

Though good progress is currently being made regarding inspections, staff is preparing door hangers that will be placed when calls for inspections start to decrease. Once calls start to decrease after the door hangers, staff is considering knocking on doors.

At the last meeting there was a question regarding a drop-off of on applications for the Lateral Loan Program. There was a slow down for a short period, but it has bounced back to a great extent.

<u>Item 5A6</u>: **CUE/CUO Report and Action Items** – *RKM/TAD*

Dashboard for Board Members - We are in the process of developing a password-protected web page specifically for Board members. Our intention is for this dashboard to provide the Board with an uncomplicated view of financial information and other various updates. In order to best proceed with development, the CUE and analyst/assistant need assistance from the Finance Director to help schedule training with NWS (the budgeting/accounting software supplier).

Below is an answer to a question asked by members:

Elyria Interconnect Construction Assistance - At the last meeting, there was discussion regarding the Construction Administration services from Burgess & Niple (B&N) and the process used to qualify them for this project. B&N was the firm hired to design the project and thus are most suited to oversee the Construction Administration, with the assistance of internal staff.

Is the lead service issue an opportunity for more public outreach? - There was discussion at the last meeting regarding the new Ohio EPA legislation that will require a utility to provide residents with water filters if the utility is performing work in an area that lead water services are present. Currently the CUE is working with the Outreach Specialist to develop an outreach program for customers who may have a lead water service at their residence.

Curtis Area Sanitary Sewer Rehabilitation Project

Per CUE's meeting write-up and this evening's discussion, Mr. Abram moved, Mr. Rush seconded to approve the submitted low bid of \$1,875,352.00 by Underground Utilities, Inc. and the CUE be authorized up to an additional 5% for other project-related items, including out-of-scope work with UUI.

Per CUE's meeting write-up and this evening's discussion, Mrs. Schnabel moved, Mr. Rush seconded to approve the CUE to complete the requirements necessary to apply for financing through the Water Pollution Control Revolving Loan Fund and execute all loan documents for the Curtis Area Sanitary Sewer Rehabilitation Project and designate user fees and revenues as the repayment source.

Reports/Updates

The following reports and updates were made by copy of the meeting's write-up and discussed as noted:

Elyria Interconnect Construction Assistance

At the last meeting, the Board authorized the CUE approximately \$187,000 for interconnect-related items outside of the scope of Engineering Fluid, Inc. Under this amount, the CUE will execute an agreement on behalf of the Board for Construction Administration of this project by Burgess & Niple. Staff is currently negotiating the final scope and budget, which may be as much as approximately 5% of the construction cost (<\$100,000). Staff currently has limited capacity to administer the project internally and is working to determine the appropriate level of oversight internally v. externally through Burgess & Niple.

Continuous Improvement

The general staff training/development is proceeding well. On Wednesday, March 28, Tri-C conducted a Process Mapping training class that introduced the organization to the concept. In May, we will specifically create maps for one process in each department. Prior to that, in April, staff training will include creating SOPs and delivering great customer service.

Now that staff readiness has reached a level for the process to take hold, the CUO and CUE met with LCCC on March 27 regarding the next steps in the Continuous Improvement process. This will include much deeper training and teambuilding for the organization's leadership so that they can help implement it across the organization.

Project Updates

- Wastewater Plant: The new headworks is in service and operational. SCADA work and training is ongoing. Reconditioned Primary Tank #1 and Final Clarifier #1 are complete and in service. Primary Tank #3 was taken out of service for rehabilitation. The new grit removal system is scheduled for start-up the week of April 1, 2018. Anticipated completion date in late June or July 2018.
- *SIP:* Additional cost proposals are being solicited for the tower lighting and project closeout documents are being finalized. Design proposal package being created.

Lateral Updates

Sewer lateral separation and loan program numbers were updated by this meeting's write-up.

CUE Report and Action Items

On March 26, 2018, the CUE in his role as Chair of the OAWWA Water Utility Council presented testimony to the Ohio legislature's Joint Committee on Agency Regulatory Review (JCARR) opposing a specific part of the Lead & Copper Regulation that was being filed to become law. The objectionable part is a requirement that utilities must offer lead-removing filters to customers during construction within an area that may have lead service lines. This new regulation that will take effect October 1, 2018, will increase project costs, and there is insufficient research available showing any increased risk (and, hence, the need for filters) for customers who are in the construction area and do not have lead service lines.

Within the past few weeks, the CUE has spoken both with Senator Gayle Manning and Representative Nathan Manning and is in the process of scheduling tours of our facilities for them. The CUE will update the Board as they are scheduled.

During the third week of April, the CUE will be part of a team of six from Ohio attending the Water Matters Fly-In in Washington, D.C. to meet with Congressional representation on water-related matters.

Recently, Avon Lake Regional Water was approached by the U.S. Department of Energy to present and serve on a panel at the national Better Building Summit, a 1,000-person conference that will be held this summer in Cleveland on August 21 – 23. DOE learned about our "Utility of the Future Today" award in 2016 and asked us to speak about some of the work we are doing regarding energy efficiency, messaging, creating stakeholder buy-in, and future goals.

AWWA partnering fee: Responding to the request for more information about this expense, the AWWA partnering fee is to become a member of The Partnership for Safe Water, which is part of our continuous improvement process. This is one of the programs recommended by our management consultant. It establishes a more-stringent standard of treatment at our drinking water facility and recognizes how well we achieve our goals.
