# Board of Municipal Utilities Work Session Minutes May 2, 2017 201 Miller Road Avon Lake, Ohio

The work session was called to order at 6:01 PM.

Present: Mr. Dzwonczyk, Mr. Phillips, Mr. Rickey, and Mr. Rush.

Also present: CUE Danielson, WPCC Manager Baytos (arrived at 6:10 PM), Engineering Services Manager Gaydar, Mayor Zilka, Councilmember Fenderbosch, Finance Director Presley, and Anthony Abram.

Finance Director Steve Presley speaks with members about the reassessment of the bond ratings by Moody's, indicating it will not have an observable effect on the City. He stressed that Moody's looked at a snapshot in time (12/31/15—the last available audited financial information). Upon questioning by members, he indicated the change in rating would not affect either Avon Lake Regional Water or the City moving forward on the 45s' combined sewer separation so long as the low-interest state revolving loan is still available. The CUE noted that OEPA views us very favorably and wants to assist with funding projects.

The chairman noted that failing infrastructure is an un-booked liability that could lead to catastrophe; and the Board's approach is to address infrastructure liabilities, which is leading to prudent investments, especially when we are able to get such attractive interest rates. Our rate increases will help stabilize the bond rating, especially because it includes a sinking fund to help prepare us for future renewal and replacement projects.

Under "Other Business," Member Rush commented that Board pay had been increased a few years ago to equal the minimum pay that would be fully credited by OPERS. However, because OPERS minimums increased, Board pay had fallen behind again. The chairman commented that the intention was for Board pay to keep up with the OPERS minimums and asked the GUE to provide information to the Board by when would any requests to Council be made.

The work session adjourned at 6:31 PM.

#### Call to Order - Roll Call

The meeting was called to order at 6:37 PM.

Present: Mr. Dzwonczyk, Mr. Phillips, Mr. Rickey, Mr. Rush, and Mrs. Schnabel (arrived at 7:37 PM).

Also present: Chief Utilities Executive Danielson, WPCC Manager Baytos, Engineering Services Manager Gaydar (left at 7:29 PM) Councilmember Fenderbosch (left at 7:14 PM), Mayor Zilka (left at 7:14 PM), and Anthony Abram (left at 6:42 PM).

### **Approve Minutes**

Chairman Dzwonczyk presented the minutes of the April 18, 2017, Work Session and the April 18, 2017, Regular Meeting and with no changes, additions or corrections noted, ordered the minutes to stand and be distributed as presented.

**Public Speakers** – Former Board Member Anthony Abram stated that the Board will be making a financial mistake by hiring a full-time Engineer and Underground Asset Locator. He believes the duties of these proposed positions do not warrant full-time employees with benefits and that these duties should be farmed out to consulting engineering firms and underground asset locator companies. He said the Board must not increase expenditures by hiring unnecessary full-time personnel. The Utility should contract with outside consultants and save money for the ratepayers.

### Job Descriptions and Wages

At Chairman Dzwonczyk's request, Engineering Services Manager Gaydar commented about the need for in-house engineering and locating assistance. He indicated that using in-house staff has saved our customers hundreds of thousands of dollars with engineering projects and that substantial workloads would keep these new positions gainfully employed. He also reminded the Board that the Engineer is a replacement for the GIS Analyst position. Following a brief discussion, Mr. Rush moved Mr. Phillips seconded to approve the job description for the Chief of Utility Operations.

### Reports/Updates

### Project Updates:

Water Tower: Tank bowl preparation and painting is starting.

Water Plant: Top soil is being spread. MWHC Staff is preparing to remove the trailer. Wastewater Plant: The Manager's office is almost complete. The new UV is up and running. Equipment for Aeration, Final tanks, and Alum tank is on site. The influent pumping station excavation is over 50% backfilled.

Lateral Updates: The lateral separation program is progressing well. As of April 27, 2017, letters have been sent to 2,944 residents indicating that they may have clean water entering their sanitary lateral and requesting Avon Lake Regional Water be contacted to determine whether this may be the case. To date, 2,134 (72%) have responded (up 57 since 4/13/17). Of the 2,134, 1,470 either have separated laterals or already had separated laterals and 664 either have problems or are believed to have problems. By extrapolation, approximately 1,200 (664 + ~67% of homes not inspected) may need to separate laterals.

Since the last Board meeting, no additional agreements for the Lateral Loan Program have been executed (however, 11 are "in process"), leaving the total to 63, with \$250,400 (total) committed and \$83,600 paid so far. The average loan request is for approximately \$3,210.

Community Outreach Specialist: Interviews for the Community Outreach Specialist were conducted on Monday, May 1. Second interviews will be scheduled the week of May 8<sup>th</sup>, 2017.

Employee Appreciation Breakfast: As a reminder, the employee appreciation breakfast will be Friday, May 5, 2017 at 8:00 AM at the Avon Lake Public Library.

#### **CUE Action Items:**

Below are responses to questions asked by the Board:

LORCO: Staff has been investigating and identifying clean water sources entering the system, and the Executive Director is addressing them. Members indicated that law enforcement may need to get involved to help customers understand the gravity of the issue.

New employees: At the request of the Board, all new employees will attend one meeting to meet Board members.

Signs in the 45s for inspections: With the loss of the temporary clerk, staff has been unable to send out additional Resolution of Necessity letters and coordinate the placement of signs. Members questioned how much time items like this take. The CUE indicated that he is requesting fulltime assistance for the lateral separation program because letters, phone calls, pulling files, coordinating inspections, and processing loans is currently approximately a fulltime job over and above the time it takes to inspect the houses. Members further questioned whether the part-time inspectors could make the phone calls, rather than hiring a fulltime clerk.

Item 4A1:

**Debt/Refinancing** – TAD

Avon Lake Regional Water worked with the City of Avon Lake last year to jointly issue one-year notes in order to help fund projects. As the notes come due, the debt for some will be moved to the state revolving loan fund. Other debt will roll over into another one-year (joint-issue) note, and one will be paid off as follows:

Note Purpose Disposition Amount **Moorewood Sewer Separation** Rolling into another note \$5,000,000 Walker Road Water Main \$2,500,000 Rolling into another note Miscellaneous Water Mains \$650,000 Paying off Moving to state revolving loan (DEFA) Fairfield-Brookfield Water Mains \$2,000,000 Fairfield-Brookfield Sewer Separation \$6,000,000 Paying down some & moving to state revolving loan (DEFA)

### <u>Item 4A2</u>: **Project Updates** – *SCB*

Water Tower: Crews will again be working 7 d/wk to paint the bowl and remain on schedule. Water Plant: Paving and landscaping is being completed.

Wastewater Plant: Mechanical equipment is being installed in the final clarifiers and the alum clarifier.

# <u>Item 4A3</u>: Lateral Updates – *TAD*

The lateral separation program is progressing well. As of May 12, 2017, letters have been sent to 2,948 residents indicating that they may have clean water entering their sanitary lateral and requesting Avon Lake Regional Water be contacted to determine whether this may be the case. To date, 2,164 (73%) have responded (up 30 since 4/27/17). Of the 2,164, 1,487 either have separated laterals or already had separated laterals and 677 either have problems or are believed to have problems. By extrapolation, approximately 1,200 (677 + ~67% of homes not inspected) may need to separate laterals.

Since the last Board meeting, 16 additional agreements for the Lateral Loan Program have been executed, bringing the total to 69, with \$287,500 committed and \$88,850 paid so far. The average loan request is for approximately \$3,230.

### <u>Item 4A4</u>: **New Employees** – *TAD*

Customer Service Clerk Nicole Huerner, who began working with Avon Lake Regional Water on May 1, 2017, will attend the meeting on May 16 in order to meet the Board. Customer Service

Item 4A5: **CUE Action Items** – *TAD* 

Below are responses to questions asked by the Board:

GLRI: The Great Lakes Restoration Initiative was launched in 2010 to accelerate efforts to protect and restore that Great Lakes by cleaning up areas of concern, preventing and controlling invasive species, reducing nutrient runoff, and restoring habitats. To date, over \$1.7 billion in projects have been funded, including more than \$14 million for restoration work and harbor maintenance on the Black River and in Lorain Harbor. The 2017 budget that Congress recently approved kept annual GLRI funding at \$300 million for the fiscal year ending 9/30/17.

Board salaries: At the May 2 work session, members asked about the timing regarding the fixing of Board salaries. Section 52 of the Charter indicates that Council must fix the salaries on or before the first day of June.

Expense sheet formatting: Staff is working to end the process of using these expense sheets generated in QuickBooks and exported to Excel. The new purchase order software, New World Systems, has the ability to create reports, but staff is still working though issues to get the functionality. The formatting issue noted on the last expense sheet related to different size fonts in the Excel worksheet used for printing. While QuickBooks remains in use, staff will assure formatting issues such as these are minimized.

Potential lateral loans: As of May 12, 2017, there are 437 known lateral problems in homes that must be separated by 2/1/18; and 587 homes have not been inspected. Of these homes not yet inspected, it is estimated 434 must separate. Therefore, an approximate 875 homes must separate by 2/1/18, which leads to approximately 100 loans per month if everyone takes out a loan. This could lead to needing up to approximately \$350,000 on-hand each month to pay contractor expenses. The Board originally advanced \$200,000 to seed the fund. We will, therefore, need to keep the seed money in the fund until after we get through separations for the first deadline.

Lateral Contractor Safety Enforcement: The City's contractor registration program primarily requires bonding and insurance. Safety requirements/enforcement is the responsibility of the state. For example OAC 4123:1-5-26 governs Trenches and Excavation.
